# **AVAILABLE OPENINGS**

Mattawan Consolidated School District will be accepting students in all grades, Young 5's through 12th grade.

• Section 105: Student resides within Van Buren County

• Section 105c: Student resides within a county which borders Van Buren County [Allegan, Berrien, Kalamazoo,

or Lewis Cass1

• PA227: Parent or legal guardian is a direct employee of Mattawan Consolidated School

## **APPLICATION WINDOW**

January 4, 2024, through January 19, 2024, at 4:00 pm

## **NOTIFICATION PROCESS**

Applicants will be notified via email {or USPS if email is not provided} of acceptance and the effective start date or denial. Enrollment information will be provided to accepted applicants. If application is denied, the notification will include the reason for denial.

## **KEY POINTS**

- You do not need to reapply every year. Once a student is schools of choice accepted, continuous enrollment
  ensues through graduation unless they withdraw. If a schools of choice student withdraws and lives outside of
  the Mattawan Consolidated School District and later chooses to enroll, they will be required to reapply through
  the Schools of Choice process. If students move outside their original district while enrolled, a new application
  must be submitted.
- Accepted students must agree to comply with all Mattawan District policies.
- According to Michigan High School Athletic Association [MHSAA], students accepted into the Schools of Choice program whom are in grades 10-12 will not be eligible to participate in sports for one semester.
- Transportation is NOT provided for Schools of Choice students.
- Students with an Individualized Education Plan [IEP] wishing to enroll under 105c Schools of Choice for whom a written cooperative agreement regarding costs cannot be obtained with their resident district may be denied Schools of Choice.
- Enrollment may also be denied to students who have been suspended, expelled, or convicted of a felony.

#### **HOW TO APPLY**

Electronically download or print the Schools of Choice application and complete all information. One application per student must be completed by the student's parent/legal guardian. You must also attach two proofs of address to your application (i.e. Voter Registration card, Driver's license, utility bill). Thank you for your understanding.
