



Advertisement for Request for Proposal Mattawan Consolidated School

Purpose:

Mattawan Consolidated School is soliciting bid tenders for the following items:

- 188 pcs of PlasmaAir PA602, Global Plasma Systems FC24, or equivalent, BiPolar Ionizers
 - *These units need not be self-cleaning, though self-cleaning alternatives will be considered*
- 48 pcs of Global Plasma Air FC48 or equivalent BiPolar Ionizers
- Up to 236 pcs of Rib TR50VA015 (or equivalent) 24v Transformers (where 24v input is required)
 - Bids for this should be offered in increments of 50, 100 & 236 as quantities may vary depending on input power requirements for the ionizers above

Substitutions for any of the above will require submission of product specifications for consideration and may require testing prior to approval.

Bids may be submitted for all or a portion of the items listed above. Mattawan Consolidated School may, at its discretion, select to purchase specific line items or all of these from particular bids. It is Mattawan Consolidated School's intention to place an order for these items on or about June 1st, 2021 with deliveries requested 2-4 weeks thereafter. All bids must include the following:

- Manufacturer's Part Number(s)
- Quantities
- Price/unit for each line item
- Any applicable shipping, delivery and handling costs
- Warranty coverage
- Est. delivery time(s) (after receipt of order)

Requirements:

Organizations wishing to participate in the bids must:

1. Submit a clearly-labeled, **sealed bid by Friday May 7, 2021 by 1:00pm** to Michael Holahan, Mattawan Consolidated School, 56720 Murray St., Mattawan, MI 49071.
2. Bids received after the due date and time listed above shall not be considered or accepted.
3. A designee of the Board of Education shall publicly open and read aloud the bids received at 56720 Murray Street, Mattawan, Michigan 49071 by the deadline, on Friday May 7, 2021 at 1:01pm in the Central Administration Building. Bidders are welcome to attend bid-opening but masks and social distancing will be required.
4. Each bid submitted shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any

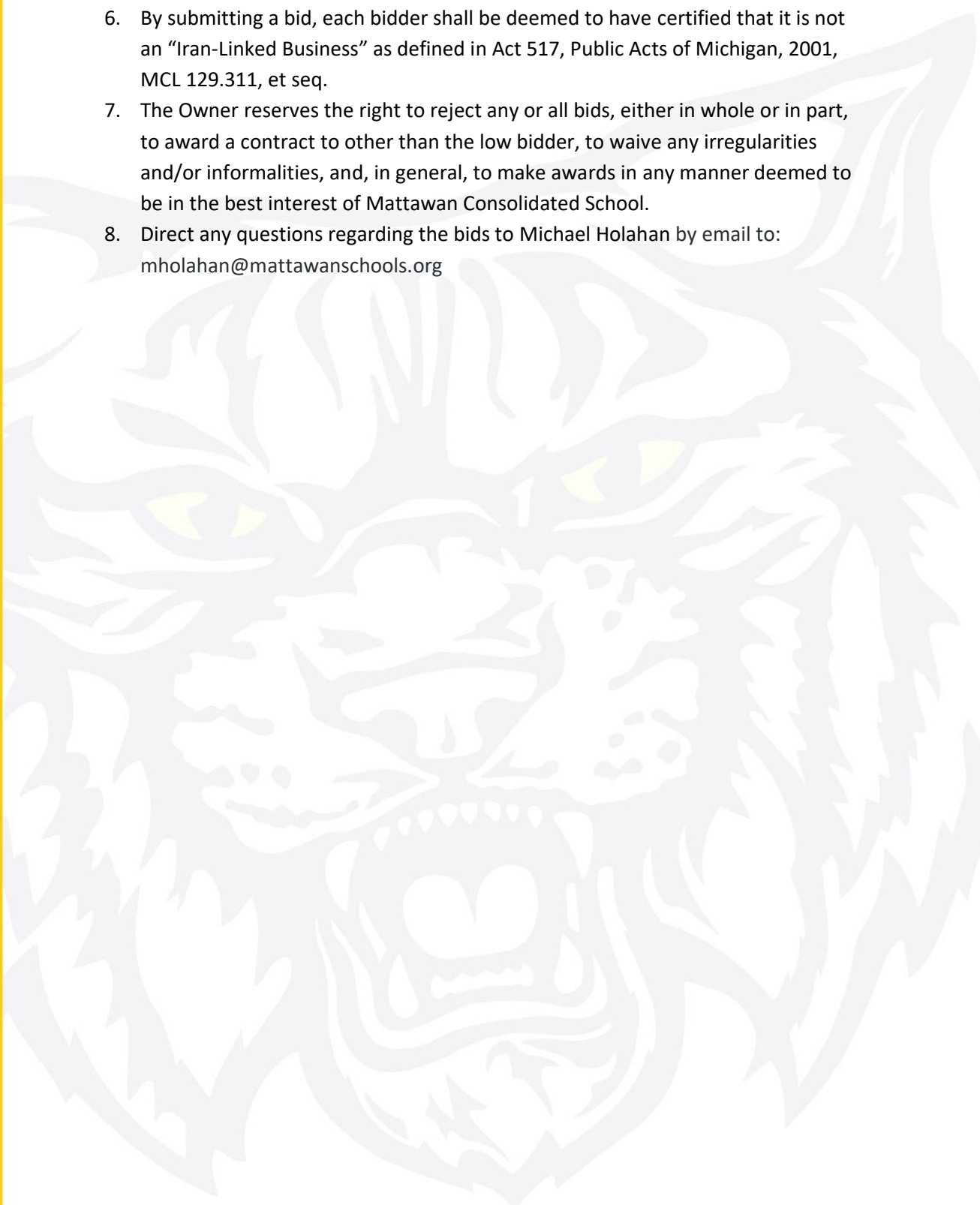

employee of the bidder and any member of the board or the superintendent of the school district.

5. Each bid submitted shall include an affidavit certifying that the vendor is not barred from public contracting due to bid rigging or bid rotating convictions.
6. By submitting a bid, each bidder shall be deemed to have certified that it is not an “Iran-Linked Business” as defined in Act 517, Public Acts of Michigan, 2001, MCL 129.311, et seq.
7. The Owner reserves the right to reject any or all bids, either in whole or in part, to award a contract to other than the low bidder, to waive any irregularities and/or informalities, and, in general, to make awards in any manner deemed to be in the best interest of Mattawan Consolidated School.
